### Presentation: What's in a name?

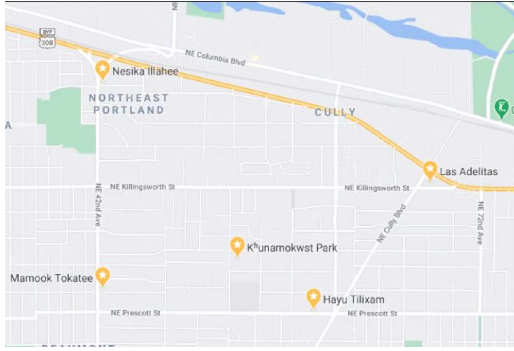
- Annette Pronk introduces Cameron Herrington and William Miller
  - Cameron Herrington, Program Manager, Living Cully
  - William Miller, Community Advocacy Manager, NAYA
- Many names we use and see everyday are indigenious names. Neerchokikoo (Near-CHO-kee-koo) village, a significant Chinook village site, is located near the slough. Portland is home to the 9th largest urban Native American population in the nation, resulting from multiple relocation acts that forced many tribal folks to move west from their homelands.
- New and upcoming non-Anglo-named places in the neighborhood,

- **Nesika Illahee (Ne-SIGH-kuh ILL-ah-hee)**, NE 42nd & Holman St, 59 homes, means, “Our Place” (Chinook) Clean and sober living, collaboration with many organizations, art on wall from elder in Chinook village, tribal print on hat is local basketry design
- **Mamook Tokatee (MAH-mook TOE-kuh-tee)**, NE 42nd Ave & Going St, 56 homes, means “To Make Beautiful” (Chinook), preference for Native artists in 42nd region, under construction, expected completion end of 2021
- **Hayu Tilixam (HIGH-you TILL-ux-um)**, 5827 NE Prescott St, 50 homes, means “Many Nations” (Chinook), reflection of removal policies, opportunity to welcome many from all walks of life, continue to give back to community in service, project of Portland Housing Bureau funded by voter-passed affordable housing bond funds
- **K<sup>h</sup>unamokwst (KAHN-ah-mockst)** Park, NE Alberta St. & 52nd Ave, means “Together”, K<sup>h</sup>unamokwst is the first PP&R park to enjoy a name indigenous to the land it sits on. Chinook wawa is the language commonly used by the original people of this area.
- **Las Adelitas (Lahs Ah-day-LEE-tahs)**, NE Killingsworth St & Cully Blvd, 141 homes, on site of former Sugar Shack and Living Cully Plaza, Ernesto will introduce at a future meeting as he could not be here tonight due to Clara Vista emergency, Alma Velazquez shares the name Las Adelitas is associated with the women who played an incredible role in the Mexican Revolution and the power that women bring to a nation

### **Presentation: Owens Brockway**

Cully Air Action Team (Gregory Sotir, Carol Pinegar, Michael Heumann) presents a letter written by Portland Clean Air to Owens Brockway, a glass recycler located near NE Killingsworth and I-205 (<http://www.cullyneighbors.org/owens-brock-letter-12-08-2021/>). Portland Clean Air compiles data about pollutants in the Portland Metro area and partners with local stakeholders to voice collective call for action. Stakeholders include neighborhood associations, City of Portland, DEQ, and others. The letter demands immediate response from Owens Brockway to install a bag filter at their Cully operation to reduce lead emissions. Additional actions (outside of this letter) include a proposed “climate tax” by the City of Portland.
